Bonnie has also been involved in the ethics system in New Jersey since 1991 and stepped down as Chair of the Disciplinary Review Board – the intermediate appellate body for the state wide attorney disciplinary system – in 2019 after serving on the Board for 13 years.

Bonnie is the 2012 Recipient of the Saul Tischler Award, bestowed upon her by the New Jersey State Bar Association Family Law Section. The award recognizes attorneys who have made substantial lifetime achievements and contributions to family law. She was selected by the New Jersey State Bar Association as the 2016 Clapp Excellence in CLE Award winner for her work in organizing and presenting seminars for the New Jersey Institute of Continuing Legal Education (NJICLE) for over 25 years. In 2021, the Morris County Bar Association recognized her with its Family Practice Award.
