## Bonnie C. Frost, Esq. to Moderate Seminar on Jurisdiction in Family Law Cases

On two consecutive Saturdays in March, 2013 Bonnie C. Frost, Esq., partner in the matrimonial department of the law firm of Einhorn, Barbarito, Frost & Botwinick, PC, will be moderating a panel discussion on ***“Jurisdiction in Family Law Cases”***, a seminar being provided by The New Jersey Institute of Continuing Legal Education.
