Nunn, who comes from a family of police officers and first responders, said, "It is an absolute honor to be a part of the Protection Plan and to be able to assist members of law enforcement." Kenney added, "Officers may be facing a civil action for which other representation is not available through their department. We are available to assist in any of these matters, and we look forward to the opportunity to do so."

Nunn, an experienced litigator in many areas of practice, is a former Assistant County Prosecutor and Municipal Prosecutor. He has handled official misconduct matters in public and private practice and he
