- *Cardali v. Cardali*, \_\_\_\_ N.J. \_\_\_\_ (2023), reversing Appellate Division decision regarding cohabitation. The case followed more than 60 appeals about cohabitation in the preceding 8 years.
- *Lapsley v. Sparta Twp.*, 249 N.J. 427 (2022), reversing Appellate Division decision regarding compensability of injuries suffered by employee in public parking lot.
- *Bisbing v. Bisbing*, 468 N.J. Super. 112 (App. Div. 2021), holding that counsel fee award in husband's favor was non-dischargeable in bankruptcy because they were in the "nature" of support and stemmed from custody proceedings.

- *Woytas v. Greenwood Tree Experts, Inc.*, 237 N.J. 501 (2019), modifying Appellate Division and concluding that outstanding financial obligations in a settlement agreement is not tantamount to the death benefit of life insurance that the decedent failed to maintain.
- *Bisbing v. Bisbing*, 230 N.J. 309 (2017), reversing sixteen years of Supreme Court case law and now requiring all child relocation decisions to be guided by a "best interests" standard.
- *Quinn v. Quinn*, 225 N.J. 34 (2016), reversing trial court and holding, in case of first impression, that Konzelman cohabitation provisions that terminate alimony are enforceable even after the "cohabitation" ends.
- *In re Child by J.E.V.*, 226 N.J. 90 (2016), requiring appointment of counsel for indigent parents in private adoptions.
- *Bisbing v. Bisbing*, 445 N.J. Super. 207 (App. Div. 2016), reversing trial court that allowed children to be relocated to Utah.
