

Matheu D. Nunn, Esq. Named To The NJBIZ 2020 40 Under 40 List

Prior to being elected to office, Nunn served as the Municipal Prosecutor of Morris Township and on its Local Ethics Board.

Nunn earned his J.D., with academic honors, from Rutgers School of Law in 2007 and his B.A. from the University of Delaware in 2003. Prior to joining Einhorn Barbarito, Nunn clerked for the Hon. B. Theodore Bozonelis, A.J.S.C. (ret.) and then for the Hon. Jack M. Sabatino, P.J.A.D.
